Filing Fee:	None, but copy fees will apply if the order is granted.
Copies:	Make 2 copies of the completed forms. The Court will file and keep the original and will endorse and return the copies to you.
Before You File:	Include a check made payable to "Sacramento Superior Court" with the amount left blank and print "Not to exceed \$50" on the memo line of the check. If the amount submitted is not sufficient to cover the cost of copies, the Court will contact you by telephone or mail to obtain the correct amount.
Filing:	All forms must be typewritten or printed in blue or black ink. (See California Rules of Court, Rules 2.100-2.119) Mail or place completed forms in the court drop-box located at the Family Court at 3341 Power Inn Road, Sacramento, CA 95826. Drop box hours are 8:00 am to 5:00 pm Monday through Friday, excluding Court holidays. Include a self-addressed stamped envelope.
