Purpose:	This packet is used to register a child custody order from another state in Sacramento County for enforcement purposes.							
Assistance:	Parties who are acting as their own attorneys may receive help from the Self Help Center to complete these forms. You may contact the Self Help Center through the Court's website, by creating an e-Correspondence account, or visit the Self Help Center in person, Monday through Thursday.							
Required Forms:	 All forms are Judicial Council forms, unless otherwise indicated: Registration of Out-of-State Custody Order, FL-580 Declaration Under Uniform Child Custody Jurisdiction and Enforcement Act (UCCJEA), FL-105 Certified copy of the Custody Order to be registered 							
Filing Fee:	There is a \$435 fee to file these documents. The current fee schedule may be found on the Court's website at: https://www.saccourt.ca.gov/fees/docs/fee-schedule.pdf .							
Copies:	Make 2 copies of the completed forms and the Custody order from the other State. The Court will file and keep the original and will endorse and return the copies to you.							
Before You File:	You must obtain a certified copy of the order you wish to register from the Court that issued the order before filing these forms.							
	You will need to submit self-addressed envelopes for each party listed on the order							
Filing:	All forms must be typewritten or printed in blue or black ink. (See California Rules of Court, Rules 2.100-2.119)							
	Completed forms must be filed in person at the Family Court at 3341 Power Inn Road, Sacramento, CA 95826 between the hours of 8:30 am and 4:00 pm Monday through Friday, excluding Court holidays. You must make an appointment online or obtain a ticket from Reception to file in person.							
Next Steps:	After filing these documents, you will receive a Notice of Registration of Out-of-State Custody Order from the Court in the envelope you provided. If the other party does not object to the Registration within twenty days, your order can then be enforced in California.
