## You may need forms that are *not* included in this packet. If you...

**NEED AN ORDER TO CHANGE YOUR NAME &/OR GENDER ON A CHILD'S BIRTH RECORD:** Complete Birth Certificate for Child of Petitioner—Attachment (NC-311). If you are asking to change your name on your adult child's birth certificate, they must sign this form if they are living. Provide the date of death if they are deceased, or explain why they are incapable of signing if they are living.

**NEED AN ORDER TO CHANGE YOUR NAME &/OR GENDER ON YOUR MARRIAGE LICENSE:** Complete Marriage License and Certificate—Attachment (NC-312). The other spouse on the marriage license must sign this form if living. Provide the date of death if they are deceased, or explain why they are incapable of signing if they are living. If the other spouse did not sign NC-312, complete Order to Show Cause—Issuance of New Marriage License and Certificate (NC-325).

#### Adult Gender Identifier (& Name) Change Packet

**FILING FEE:** The filing fee for a Petition for Recognition of Change of Gender and Sex Identifier is **\$435.00**, unless you qualify for a fee waiver (forms not included).

**COPIES:** The original plus two (2) copies of all documents are required at the time of filing (3 total). The court cannot make copies for you at the filing window. A public copy machine is available in Room 212 at 813 6<sup>th</sup> Street. Copies cost 0.25 cents per page. The machine takes cash only.
