

# Minor Gender Identifier (& Name) Change Packet

Sacramento Superior Court Civil Self-Help Services

To change the gender identifier and/or name of a minor.

## The following forms are required for name and/or gender identifier change and are included in this packet.

NC-500 — Petition for Recognition of Minor's Change of Gender and Sex Identifier
 - and Change of Name

**NC-110** — Attachment to Petition for Name Change

NC-520 — Order to Show Cause - Recognition of Minor's Change of Gender and Issuance of New Birth Certificate (and Change of Name)

NC-530 — Order Recognizing Minor's Change of Gender and Sex Identifier (and Decree Changing Name.

We do not have a form-filler for Minor Gender Identifier (& Name) Change. The attached forms are fillable .pdfs.

If you want to ask the Court to waive the \$435 filing fee, you will also need:

FW-001 – Request for Fee Waiver

FW-003 - Order on Fee Waiver

# You may need forms that are *not* included in this packet. If you are...

**ONLY ONE PARENT FILING FOR MINOR:** The non-signing parent must be served with the Order to Show Cause (NC-520) at least 30 days prior to the hearing. After service is complete, file the Proof of Service of Order to Show Cause (NC-121). If you can't locate the non-signing parent, you can complete a Declaration of Diligent Search and Request to Dispense with Notice Re: Petition for Change of Name (CV/E-208).

A GUARDIAN FILING FOR MINOR: Complete Declaration of Guardian (NC-110G) and attach behind NC-500 and NC-110. Additionally, use the Decree Changing Name by Guardian (NC-530G) INSTEAD of NC-530.

### Minor Gender Identifier (& Name) Change Packet

**FILING FEE:** The filing fee for a Petition for Recognition of Change of Gender and Sex Identifier is \$435.00, unless you qualify for a fee waiver (forms not included).

**COPIES:** The original plus two (2) copies of all documents are required at the time of filing (3 total). The court cannot make copies for you at the filing window. A public copy machine is available in Room 212 at 813 6<sup>th</sup> Street. Copies cost 0.25 cents per page. The machine takes cash only.
