Sacramento Superior Court Civil Self-Help Services

For Name Changes filed by participants in the Safe at Home address confidentiality program.

The following forms are required for name change and are included in this packet.

- **NC-400** Confidential Cover Sheet– Name Change Proceeding Under Safe at Home (one for each form in this packet)
- NC-100 Petition for Change of Name
- NC-110 Attachment to Petition for Name Change
- NC-120 Order to Show Cause Change of Name
- NC-130 Decree Changing Name

We do not have a form-filler for Safe at Home Name Change. The attached forms are fillable .pdfs. If you want to ask the Court to waive the \$435 filing fee, you will also need: **FW-001** – Request for Fee Waiver **FW-003** – Order on Fee Waiver

Before starting a Petition for Change of Name Under the Safe at Home Program, you must be a registered participant of Safe at Home through the Secretary of State's Office. This program provides survivors of domestic violence, stalking, sexual assault, and human trafficking a way to keep their address confidential. It also allows participants to file a confidential name change with the court. You can find more information about this program at SafeAtHome.sos.ca.gov

You must include a letter from the Secretary of State's office confirming you are an active participant in Safe at Home, and that you have filed (with them) a Notice of Intent of Name Change

Change of Name Under Safe at Home CV/E-142-S (Rev. 1.1.23)

You may need forms that are *not* included in this packet. If you are...

FILING FOR MORE THAN ONE PERSON: A separate **NC-110** must be completed for EACH PERSON requesting a name change listed in the Petition for Change of Name. If you are filing for an entire family, you may also need Attachment (**MC-030**) to list more than 3 people on each form.

ONLY ONE PARENT FILING FOR MINOR: The non-signing parent must be served with the Order to Show Cause **(NC-120)** at least 30 days prior to the hearing. After service is complete, file the Proof of Service of Order to Show Cause **(NC-121)**. If you can't locate the non-signing parent, you can complete a Declaration of Diligent Search and Request to Dispense with Notice Re: Petition for Change of Name **(CV/E-208)**.

A GUARDIAN FILING FOR MINOR: Complete Declaration of Guardian (NC-110G) and attach behind NC-100 and NC-110. Additionally, use the Decree Changing Name by Guardian (NC-130G) INSTEAD of NC-130.

***NC-410** — Application to File Documents Under Seal in Name Change Proceeding Under Safe at Home

***NC-420** — Declaration in Support of Application to File Under Seal *File only if you want to file the entire case under seal.

- When you fill out the forms, you will not enter the name you are changing to.
 Rather, you will be writing in, "Confidential
 – on file with Safe at Home"
- Put a separate NC-400 in front of each different form. You will put one NC-400 on top of NC-100 and all NC-110s.
- This county will not make an order requiring the California Department of Public Health to seal and replace your original birth certificate. You will only be able to get an amendment to your birth certificate which adds a second page to the original.

FILING FEE: The filing fee for a Petition for Change of Name is **\$435.00**, unless you qualify for a fee waiver (forms not included).

COPIES: The original plus two (2) copies of all documents are required at the time of filing (3 total). The court cannot make copies for you at the filing window. A public copy machine is available in Room 212 at 813 6th Street. Copies cost 0.25 cents per page. The machine takes cash only.

If a petition to change the name of a child has been filed by a guardian, the guardian must (1) provide notice of the hearing to any living parent of the child by personal service at least 30 days before the hearing, or (2) if either or both parents are deceased or cannot be located, serve notice of the hearing on the child's grandparents, if living, not less than 30 days before the hearing under Code of Civil Procedure section 413.10, 414.10, 415.10, or 415.40.
