

Petition for Temporary Guardianship

Considerations before you file for Temporary Guardianship:

- If you wish to remove a child from a dangerous situation, the appropriate course of action is to call Child Protective Services (CPS) or local law enforcement for assistance.
- The child should be residing with you when you file your petition for guardianship.

<u>Guardianship of the Person</u> – You may not need to go through Court hearings to establish guardianship of the person. Read the Caregiver's Authorization Affidavit Coversheet before you begin work on this packet. This simple form allows a relative to enroll a child in school and to authorize medical and dental treatment. The Court has attached a copy of that form for your use. <u>Guardianship of the Estate</u> – When a guardianship of the estate is granted, the law requires the Petitioner to post a bond and to periodically report to the court. Self-represented parties typically do not qualify for a bond, and even if they do, bonds are expensive. An alternative to Guardianship of the Estate that you may want to consider is requesting an order for a blocked account, which will protect the minor's funds until he or she reaches 18.

Review the California Probate Code regarding Guardianships, beginning with section 1510 through section 1543 before completing these forms. You can review the California Probate Code at the Public Law Library and on the web at http://www.leginfo.ca.gov/calaw.html.

ASSISTANCE
