## **Request to Renew CHRO**

Sacramento Superior Court Civil Self-Help Services

To ask the Court to renew an existing restraining order.

You may ask the Court to renew a permanent Civil Harassment Restraining Order After Hearing (CH-130) no more than 90 days before it expires.

The request to renew must be filed before 11:30 AM the day before it is set to expire AT THE LATEST.

The Court will not renew an expired order.

We do not have a form-filler for CHRO Continuance. The attached forms are fillable .pdfs. There is no charge to request renewal of a Civil Harassment Restraining Order.

## The following forms are required to renew an existing CHRO and are included in this packet.

CH-700 Request to Renew Restraining Order
CH-710 Notice of Hearing to Renew Restraining Order
CH-730 Order Renewing Civil Harassment Restraining Order

## IF YOU...

**NEED MORE ROOM FOR AN ANSWER:** You may either use a blank sheet of 8.5 X 11 paper, or Attachment (MC-025).

WANT TO PROVIDE PICTURES OR SCREENSHOTS AS EVIDENCE: You may attach evidence (pictures, screenshots, etc.) to the end of form CH-700 as proof of how the person is harassing you. If you have video or audio of the person harassing you, you can submit those to the court on a USB drive (2 USB drives for the Court and 1 USB drive for the person you are filing against.) Note: The Sacramento Sheriff's Civil Bureau will not serve a CHRO request with USB drive attached. You may submit video or audio evidence at a later time, or see if the judge will allow you to present it at the hearing. You are not guaranteed the chance to present evidence at the hearing.

**NEED AN INTERPRETER:** Ask the clerk or Self-Help Staff to request an interpreter to be present for your hearing.

**FILING FEE:** There is no filing fee to ask the Court to renew an existing restraining order.

**COPIES:** The original plus one (1) copy of all documents are required at the time of filing (2 total). The court cannot make copies for you at the filing window. A public copy machine is available in Room 102 at 720 9<sup>th</sup> Street. Copies cost 0.25 cents per page. The machine takes cash only.

At the hearing, the judge can renew the current restraining order for up to another five years. You *must* continue to obey the current restraining order until the hearing. At the hearing, you can tell the judge if you do not want the order against you renewed. If the restraining order is renewed, you *must* obey the order even if you do not attend the hearing.

If you wish to make a written response to the request to renew the restraining order, you may fill out form CH-720, *Response to Request to Renew Restraining Order*. File the original with the court before the hearing and have someone age 18 or older-**not you**-mail a copy of it to the protected person at the address in 1 at least \_\_\_\_\_\_ days before the hearing. Also file form CH-250, *Proof of Service of Response by Mail*, with the court before the hearing.

- CH-720, Response to Request to Renew Restraining Order (blank copy);
- CH-130, the current Civil Harassment Restraining Order After Hearing for which renewal is requested.
