If you want to ask the Court to waive the \$435 filing fee, you will also need:
FW-001 – Request for Fee Waiver
FW-003 – Order on Fee Waiver

You may need forms that are *not* included in this packet. If you are...

ONLY ONE PARENT FILING FOR MINOR: The non-signing parent must be served with the Order to Show Cause (**NC-125**) at least 30 days prior to the hearing. After service is complete, file the Proof of Service of Order to Show Cause (**NC-121**). If you can't locate the non-signing parent, you can complete a Declaration of Diligent Search and Request to Dispense with Notice Re: Petition for Change of Name (**CV/E-208**).

A GUARDIAN FILING FOR MINOR: Complete Declaration of Guardian (**NC-110G**) and attach behind **NC-100** and **NC-110**. Additionally, use the Decree Changing Name by Guardian (**NC-130G**) INSTEAD of **NC-130**.

FILING FEE: The filing fee for a Petition for Change of Name to Conform to Gender Identity is **\$435.00**, unless you qualify for a fee waiver (forms not included).

COPIES: The original plus two (2) copies of all documents are required at the time of filing (3 total). The court cannot make copies for you at the filing window. A public copy machine is available in Room 212 at 813 6th Street. Copies cost 0.25 cents per page. The machine takes cash only.

2. THE COURT ORDERS that any person objecting to the name changes described above must file a written objection that includes the reasons for the objection **within six weeks of the date this order is issued**. If no written objection is timely filed, the court will grant the petition without a hearing.

3. A hearing date may be set only if an objection is timely filed and shows good cause for opposing the name change. Objections based solely on concerns that the proposed change is not the person's actual gender identity or gender assigned at birth do not constitute good cause. (See Code Civ. Proc., § 1277.5(c).)

NOTE: When a petition has been filed to change the name of a minor to conform to gender identity and the petition does not include the signatures of both living parents, the petition and this order to show cause must be served on the parent who did not sign the petition, under Code of Civil Procedure section 413.10, 414.10, or 415.40, within 30 days from the date on which the order is made by the court.
