

# Motion to Terminate GVRO Step 1 Packet

Civil Self-Help Services

To ask the Court to Terminate an existing permanent Restraining Order.

### The following forms are required for a Motion to Terminate GVRO and are included in this packet.

**GV-600** — Request to Terminate GVRO

**GV-610** — Notice of Hearing on Request to Terminate GVRO

**GV-630** — Order on Request to Terminate GVRO

There is no form-filler for a Motion to Terminate GVRO. The attached forms are fillable .pdfs.

There is no filing fee for this process.

# You may need forms that are *not* included in this packet. If you...

**NEED MORE ROOM FOR AN ANSWER:** You may either use a blank sheet of 8.5 X 11 paper, or Attachment (MC-025).

**NEED AN INTERPRETER:** Ask the clerk, or Self-Help Staff to request an interpreter to be present for your hearing.

**WANT TO PROVIDE SCREENSHOTS OR OTHER EVIDENCE:** This process is not an opportunity to "re-litigate" the case. However, if you have new evidence that supports why the permanent Restraining Order should be modified or terminated, you may attach that to **GV-600**.

**FILING FEE:** There is no filing fee.

**COPIES:** The original plus one (1) copy of all documents are required at the time of filing (2 total). The court cannot make copies for you at the filing window. A public copy machine is available in Room 102 at 720 9<sup>th</sup> Street. Copies cost 0.25 cents per page. The machine takes cash only.
